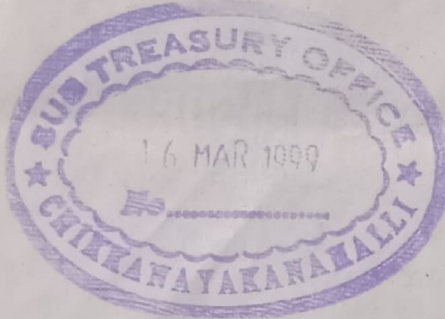

VII. The Trustees shall administer the Trust for promoting and encouraging the course of Education, Medical Relief, Community Service and Social Pursuits in all possible ways.

VIII. The Trustee shall discharge their functions to duly subservice the objects and purpose of the Rotary Education Trust and Rotary Education Trust fund shall be utilised only for the purpose of the Rotary Education Trust and shall not be used for any other purpose.

IX. The Trustees shall endeavour to augment the resources of the Trust and shall strive to widen the scope of service of the Trust in the field of Education, Medical Relief, Community service and other social pursuits.

X. The Trustees shall utilise the fund and the income from the fund for such purposes as they may consider best from time to time, such that the objects and purposes of the Trust be achieved.

XI. The Trustees shall have the power to acquire, possess, own, hold and enjoy all property movable and immovable for and on behalf of this trust, to sell, dispose alienate, encumber, lease all such property for and in the name of the Trust and to derive income therefrom and to invest to such income as they may consider best.

XIII. The Trustees are authorised to co-opt additional Trustees. It is hereby declared that the Trustees shall have power to wind up this Trust or charitable society having similar objects, if the Trustees decide that the objects of this Trust could be better served by taking such a step and within limits of the law.

XIII. Trustees shall pay or discharge any rent or other outgoing, charges, of payments in respect of any property held by them for the General purposes of any such property and to insure the same against loss or damage by fire and to defray the cost and expenses including agents fees incurred by them in so doing out of the income or capital of the Trust property at the discretion of the Trustees.

XIV. The Trustees shall at their discretion invest any money in their hands in any manner in which according to the law for the time being in force Trust money may be invested. The investments will be in accordance with the provisions of Section 11 to 13 of Income Tax Act, 1961. They have the power from time to time to vary such investments provided always that any moneys or investments arising or made as mentioned above the income thereof shall be held upon the Trust on which the property represented by such moneys or such investments, add the income thereof respectively would have been subject to, if such property had been retained by the Trustees.

XV. The Trustees shall be at liberty to do all such acts as are necessary to realise the object and purpose of the Trust and all such acts shall be binding on the Trust.

XVI. The Trustees shall have power to frame such subsidiary rules of business and shall have power further to alter and to or amend the same from time to time as may be make necessary for the conduct of their business not in insistent with the provisions of section 80(g) of Income Tax Act, 1961.

BYELAWS OF THE TRUST SHALL BE AS FOLLOWS:-

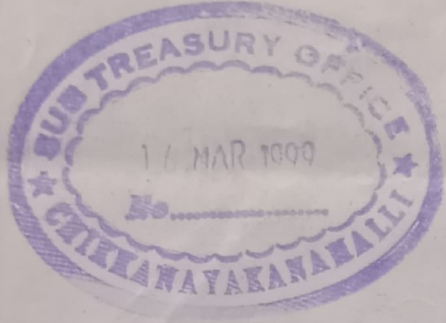
1. The activities of the Trust shall be confined to the objects set-out in the deed of Trust.

 - e) Words in singular number shall include the plural and words in the masculine gender shall include feminine.
- III. TRUSTEES:- The Trustees of the Trust shall be residents in India and any Trustee who leaves India permanently shall be deemed vacate his office. He shall be a member of the ^{Trust Education Trust} Rotary ~~Club~~ of Chikkanayakanahally The President and Secretary of the Rotary ^{Trust Education Trust} ~~Club~~ of Chikkanayakanahally shall be Honorary Ex.Officio ^{Trust} Trustees during the ^{Calendar} Rotary year.

V. BOARD OF TRUSTEES:- The Board of Trustees is initially constituted by Ten Trustees including Ex-Officio president and Secretary mentioned in this Deed of Trust and they are authorised to Co-opt two or more even numbers of more trustees if they so desire who wholeheartedly subscribe to the object of this Trust.

VI. A Vacancy caused in the office of the Trustees shall be filled by admitting another trustee in the vacancy so caused with the consent of the majority of the trustees.

VII. The President of the Rotary Education Trust of C.N.Halli shall always be the President of the Rotary Education Trust and the secretary of the Rotary Education Trust of C.N.Halli shall always be the Secretary of the Rotary Education Trust to look after the administrators of the Trust.

VIII. POWER OF TRUSTEES:-

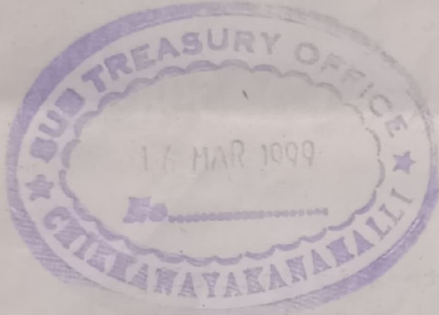
- i) Rules shall be interpreted by the trustees whose decision shall be final and binding.

IX.

- i) The cash contributions including the initial donation of the settlors and other properties (movable and immoveable) as may be donated or otherwise acquired by the trust shall be the properties of the Trust.
- ii) The properties of the Trust shall vest in the Board of Trustees duly represented by the President of the Trust.
- iii) The President of the Trust duly authorised by the Board of Trustees shall have the power to convert any property of the Trust, in any manner and to any form suitable to the requirements of the Trust.

X. MANAGEMENTS.

- i) The Management of the affairs of the Trust shall vest in the Board of Trustees who has generally manage the affairs of the Trust through the President of the Trust.
- ii) The President of the Trust shall guide and direct the Secretary in regard to the administration of the Trust. The Secretary shall be subordinate to the Trust. The Secretary shall be subordinate to and is responsible to both of them. In the absence of the Secretary the President shall perform the duties of the Secretary.

XI. MEETINGS:- The Trustees shall meet as often as the Circumstances require, to transact the business of the Trust, so however, there shall be at least Four meetings of Trustees in a year. The Secretary shall convene the meeting of the Trusts and prepare an agenda of the items to be discussed and decided in such meeting. The Secretary or other person appointed by the Board shall be responsible for recording the minutes of the meeting of the Trustees and to carry out the directions contained in the resolution passed in the said meeting. He shall report to the President of the Trust of the action taken by him in implementing the resolutions or directions of the Trustees.

XII. RESOLUTION BY CIRCULATION:-

It shall be open for the Board of Trustees to adopt any resolution by circulating the same amongst the Trustees provided such a resolution is assented by a majority of the Trustees.

XIII. BYE LAWS:- The Board of Trustees may from time to time frame or amend bye-laws as may be necessary for carrying out these objects of the trust and to implement these rules by providing for the holding of the meetings, defining the functions and powers of the president of the Trust, Secretary and the other employees of the Trust and such other matters concerning the administrations of the Trust.

a) The Trustees shall be the sole authority in appointing or relieving the employees of the Rotary School run by the Rotary Education Trust in the interest of the School.

XIV. LEGAL PROCEEDINGS:- All legal proceedings by or against the Trust shall be instituted or carried in the name of the Trust by the President of the Trust. And shall be Instituted only in the court within the local jurisdiction of the Trust.

XV. INDEMNITY:- Every Trustee and the Secretary the Trust shall be indemnified out of the funds of the Trust against all losses or expenses incurred in the discharge of his duties except such as shall happen through his willful neglect or dishonesty and such Trustee shall be chargeable for such money, funds or property as he shall be have actual ly misused or mishandled.

XVI. ACCOUNTS:-

- 1) The Secretary shall be the custodian of all the records and documents relating to the Trust, The Secretary shall keep proper books of accounts and cause of record, the receipts and payments and also maintain documents relating to these transactions. The accounts shall be audited once a year by an Auditor empowered to audit the account of companies.
